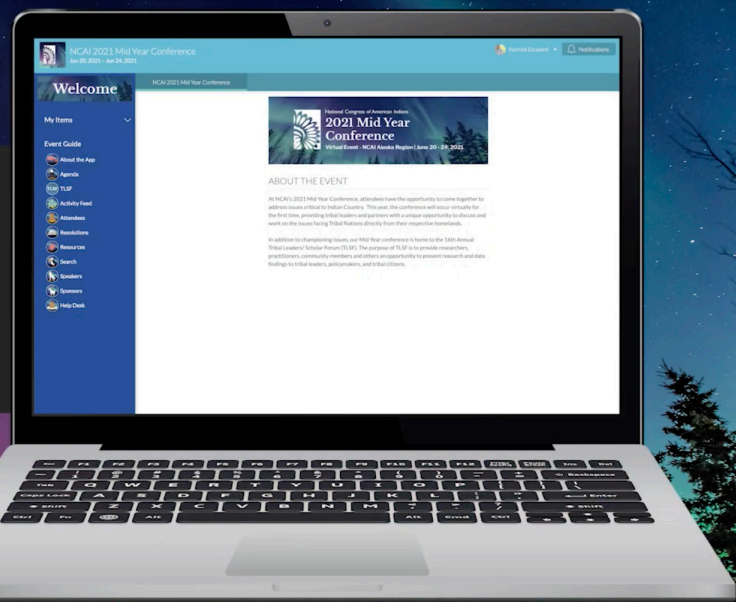

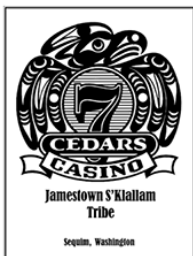

NCAI Board, Tribal Leaders, and Conference Attendees:

Welcome to the 2021 Mid Year Conference! I'm happy to see that you are holding this conference virtually in NCAI's Alaska Region. As the senior Senator for Alaska, I welcome you all virtually to my home state and look forward to welcoming you in person in the future.

Alaska is home to 40 percent of all federally recognized Tribes. Each Alaska Native community and Tribe across the nation is unique and carries different histories and cultures. These types of conferences help us understand the diversity of Indigenous peoples as well as appreciate the issues in common across all Tribal nations and communities.

I have the honor of serving Alaska and working on behalf of Native peoples through a number of committees in the Senate. Currently, I am the Vice Chairman of the Senate Committee on Indian Affairs; Ranking Member on the Senate Committee on Appropriations, Interior, Environment, and Related Agencies Subcommittee; and Member of the Senate Committees on Energy and Natural Resources, and Health, Education, Labor and Pensions. During my time on the Indian Affairs Committee, I helped shepherd the reauthorization of the Indian Health Care Improvement Act and Tribal Law and Order Act through the Senate. I have overseen implementation of two important laws to Alaska, the Alaska Native Claims Settlement Act and the Alaska National Interest Lands Conservation Act, including its crucial subsistence provisions. More recently, working hand in hand with Tribal advocates, I have been engaged in multiple bipartisan efforts to create enduring policy and provide federal resources to address the missing and murdered Indigenous women (MMIW) crisis and stop violence against women. As part of that, I was honored to lead efforts to pass Savanna's Act and the Not Invisible Act. And in FY20 and FY21, I included more than \$6 million in my Interior appropriations bill to address the MMIW epidemic.

Your meeting provides an opportunity for Tribal leaders to share their experiences, learn from each other, and develop consensus policy positions. With the input of advocates in Alaska and across the nation, I am grateful to have advanced policy priorities for all American Indians, Alaska Natives, and Native Hawaiians, but we know much work remains. Again, welcome to Alaska, America's only Arctic state, and I wish you all a productive conference!

Dear Tribal Leaders,

Welcome to the National Congress of American Indians 2021 Mid Year Conference. This year, the Conference will occur virtually for the first time. Although I'd prefer to see you all in person, I'm grateful that you will have the opportunity to come together and address issues critical to Native communities.

I was also glad to learn that NCAI has chosen Anchorage to host the 2022 Mid Year Conference. I hope you can attend next year and, for those who will visit from outside the state, enjoy the great state of Alaska.

I will continue fighting in Congress on many fronts for the empowerment of American Indians and Alaska Natives. I look forward to hearing from you after the Conference about the challenges facing Tribes and NCAI's strategies for overcoming these obstacles. We have much to accomplish during the remainder of this Congress, and as the Ranking Member of the House Natural Resources Subcommittee for Indigenous Peoples of the United States, I will do everything I can to advance legislation that improves the lives of Natives throughout the nation.

As a point of privilege, I'll also mention that in December, we will celebrate the 50th Anniversary of the signing of the Alaska Native Claims Settlement Act (ANCSA). This ground-breaking legislation helped to create the unique system we have in Alaska. It encourages self-determination and cultural perpetuation for the 229 federally recognized Alaska Native Villages and Tribes through 174 Alaska Native Village Corporations, 12 Alaska Native Regional Corporations and numerous Native-run non-profits from tribal health consortia to Native housing authorities. It is an interconnected and intricate system that relies on everyone working together for the benefit of all Native communities and the state of Alaska.

While Tribal unity on issues can be elusive and is not always warranted, it is a tremendously powerful force that can drive positive political change. I urge you to use this Conference as an opportunity to seek common ground on controversial issues. When Native voices unite on a tough topic, the consensus helps to clear the path so that Tribal allies in Congress can make real progress.

May your time at the Conference be rewarding, leave you energized, and empowered to continue your pursuits in championing policies and solutions that will meet the needs and dreams of all Native communities.

The NCAI Resolutions Committee consists of Tribal Volunteer Co-Chairs and Executive Board Liaisons. The committee will review submitted resolutions and develop recommendations.

Submitted Resolutions Posted to NCAI Website

Submitted resolutions and recommendations will be posted to the NCAI website one week before the conference begins for sponsors and attendees to review. A broadcast will be sent to NCAI members when the documents are posted online.

At the time that the resolutions and recommendations are posted online, notice will be sent to committee and subcommittee co-chairs to review resolutions assigned to their committees.

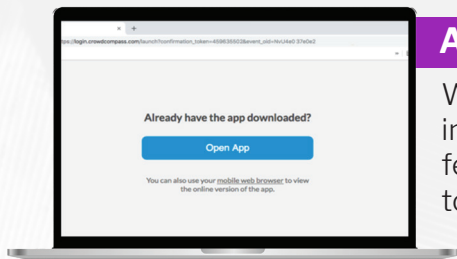

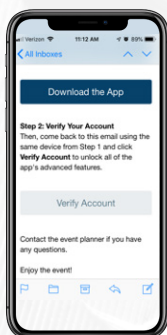

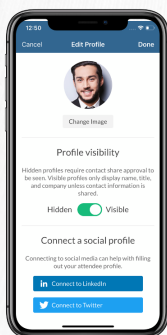

Fawn R. Sharp serves as the 23rd President of the National Congress of American Indians. President Sharp was elected on October 24, 2019 at NCAI's 76th Annual Convention & Marketplace. President Sharp is the third woman to hold the position of NCAI President. President Sharp is the current Vice President of the Quinault Indian Nation in Taholah, Washington, after being a five term past-President. Ms. Sharp has held numerous leadership positions and has conducted lectures and publications all over the United States.

**First Vice President Aaron Payment, NCAI*****Chairperson, Sault Ste. Marie Tribe of Chippewa Indians***

Chairperson Aaron Payment is serving in his second term as Chairperson of the Sault Ste. Marie Tribe of Chippewa Indians. With 42,000 members, his Tribal Nation is the largest east of the Mississippi. He has served as a Tribal Council Member, Vice-Chairperson, and is now in his second four-year term as Chairperson. Chairperson Payment has been in tribal elective office for nearly 14 years.

**Recording Secretary Juana Majel-Dixon, NCAI*****Traditional Legislative Councilwoman, Pauma Band of Mission Indians***

Juana Majel-Dixon has served as the Traditional Legislative Councilwoman for the Pauma Band of Mission Indians since 1970. In this capacity, she has been involved in many Native American issues including but not limited to: Public Law 280, Self Determination (63E), Indian Education Act, Native American Religious Freedom Act, Native American Graves Protection Regulatory Act, the Indian Child Welfare Act, Violence Against Women Act and Tribal Law and Order Act.

**Treasurer Shannon Holsey, NCAI*****Tribal President, Stockbridge-Munsee Band of Mohican Indians***

Shannon Holsey serves as President of the Stockbridge-Munsee Band of Mohican Indians. President Holsey has served three terms as president following 8 years as a member of the Tribal Council. President Holsey grew up on the Stockbridge-Munsee reservation in Bowler, Wisconsin, and has committed the Tribe to serving as good stewards of its economic, environmental and culture as well as intellectual resources.

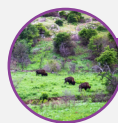

Mitigating, Responding, and Recovering from the COVID-19 Pandemic: Accessing FEMA Resources to Protect Tribal Citizens Today (session will go until 7:00 p.m.)

On March 13, 2020, the past administration issued a Presidential Nationwide Emergency Declaration to combat the COVID-19 pandemic. The Emergency Declaration covered all 574 Tribal Nations and provided an avenue for those Nations to directly access Public Assistance resources from FEMA. Despite over a year passing, only 15 percent of all Tribal Nations, 91 of the 574, have been able to access FEMA resources either as a direct- or sub-recipient under the Nationwide Emergency Declaration, or under a Tribal Major Disaster Declaration. On April 2, 2021, FEMA leadership committed to supply every Tribal Nation that is interested in accessing FEMA Public Assistance COVID-19 resources with a dedicated FEMA program delivery manager to help the Nation navigate the complex FEMA process. During this breakout, FEMA will discuss how it is working to ensure that one hundred percent of Tribal Nations are able to directly access and utilize FEMA COVID-19 resources on the ground in Indian Country. Tribal emergency managers will also provide insights into the process to access FEMA resources through the Nationwide Emergency Declaration and a Tribal Major Disaster Declarations.

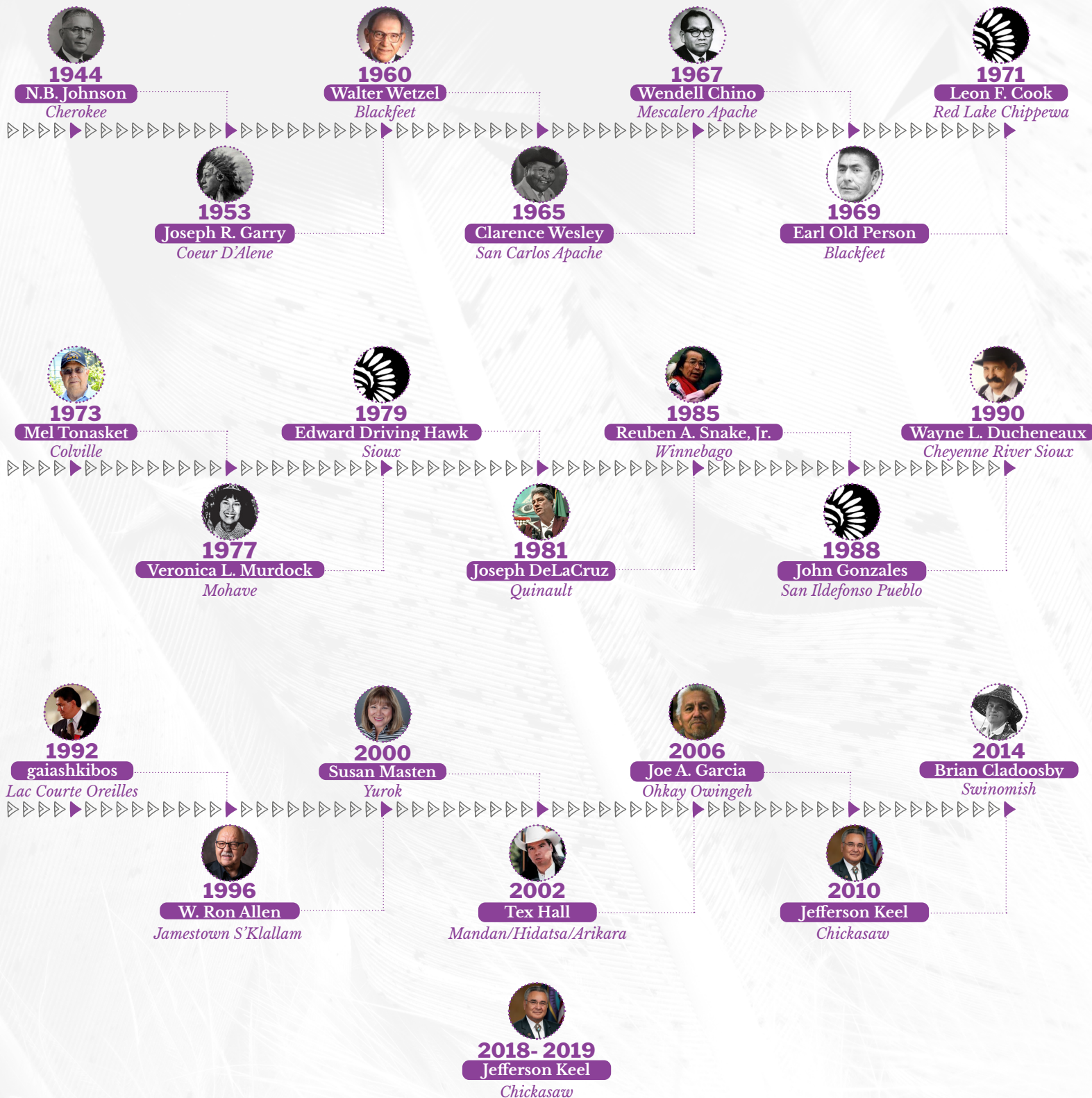
