The NCAI Tribal Temporary Assistance for Needy Families (TANF) Task Force will discuss current Administrative and legislative initiatives impacting Tribal TANF nationally, with the goal of highlighting solutions and discovering best practices in order to overcome barriers to the delivery of programs. The Tribal TANF Task Force has consistently supported goals to increase tribal nations' authority to administer their own family support and work readiness programs, and will continue to identify solutions to increase program efficiency.

#### **NCAI Federal Recognition Task Force**

The Federal Recognition Task Force works to address the unique interests of non-federally recognized tribal nations, including issues such as the federal acknowledgment process, how

non-federally recognized tribal nations work with state and local entities, and other issues. The Federal Recognition Task Force invites all interested tribal nations and citizens to participate.

## **NCAI Large Land Base Tribal Nations Task Force**

The purpose of the Large Land Base Tribal Nations Task Force is to strengthen the ability of NCAI to advocate for the unique issues of tribal nations with large land bases, and to foster unity and cooperation among all tribal nations to preserve tribal sovereignty, lands, cultures, and quality of life for all. The Task Force will govern its own proceedings consistent with this purpose.

#### **NCAI Addiction Task Force**

The NCAI Addiction Task Force will discuss administrative and legislative priorities to increase access and improve the function of behavioral health and addiction programs at the tribal level. The Addiction Task Force has consistently supported efforts to advance education, treatment, preventative services, and public safety in tribal communities.

The development and availability of accurate data in Indian Country is important to understanding the proper levels of funding for important programs. Without accurate data, it is impossible for the federal government, tribal nations, and Congress to understand the scope and breadth of unmet needs, and the development of a sufficient budget and appropriations that honors the trust responsibility the United States has to tribal nations. The Task Force invites those interested in finding ways to solve this problem, and what important policy priorities will be impactful in solving the lack of accurate data for Indian Country.

## **NCAI Climate Action Task Force**

The working mission of the Climate Action Task Force (CATF) is to "document, inform, and support the climate action efforts of tribal nations and Native organizations, and identify and advocate for policies and funding designed to empower their ability to engage in effective, sustainable climate action."

## **Economic Recovery Starts Within: COVID-19's Wake-Up Call for Indian Country**

#### From Requests to Resources: Navigating FEMA during the COVID-19 Pandemic

On March 13, 2020, the President declared a nationwide emergency, which opened the door for all tribal nations to access disaster resources from the Federal Emergency Management Agency (FEMA). Despite that door being opened, only a fraction of tribal nations have been able to access those lifesaving resources. During this breakout, speakers will provide a COVID-19 update and will walk tribal nations through the process to access COVID-19 disaster resources. Tribal emergency managers will also provide insight on how tribal nations can avoid common pitfalls in the FEMA process.
